The applicant requests oversight by UDEQ of investigation and cleanup activities of possible contamination at the property described above and intends to enter in good faith a written agreement with UDEQ to provide voluntary program oversight. This application does not constitute such an agreement, and neither UDEQ or the applicant will be bound to proceed with voluntary oversight unless such an agreement is executed. Applicant should be aware, that in order for UDEQ to issue a Certificate of Completion for an entire site, the applicant must provide adequate information to document that the entire site meets the applicable standards. As an alternative, the applicant may pursue a Certificate of Completion for only a portion of the site, as a partial response action area. The agreement will describe the project activities of each party and will require applicant to reimburse UDEQ for all of its oversight costs. By completing and signing this application, the undersigned affirms the applicant's financial capability to perform the voluntary cleanup. The Executive Director may request additional information to support this affirmation.

With this application, the applicant does not admit or assume liability for investigation or cleanup of the site. In addition, the applicant may terminate the application at any time. If UDEQ

rejects the application, the procedures in section 19-8-105 of the Utah Code will be followed by UDEQ.
